

# Residential ENERGY EFFICIENCY Rebate Program & Heat Pump Financing Program

Southwest Tennessee Electric EMC and TVA have partnered to offer you an opportunity you will not want to pass up. eScore is a residential energy efficiency program that provides you, our members, with a clean path to make your home as energy efficient as possible. The program allows you to make qualified energy improvements at a pace you can afford. eScore provides a home energy scorecard that gives you a simple path for a single family homeowner to score a perfect 10 by completing a list of energy efficient improvements.

Participate in eScore and save future energy dollars, improve the value of your home and receive cash incentives!

If you are a Southwest Tennessee EMC member, own a single-family residence, and wish to participate in the eScore program, you have two options in which you can participate:

- 1 You can register for eScore at <a href="www.2escore.com">www.2escore.com</a> and call your local Southwest Tennessee EMC member service center. You may choose to have an evaluation performed on your home for a \$175 non-refundable fee which is charged to your electric bill.
- To save the \$175 fee, you can register for eScore online at <a href="https://www.2eScore.com">www.2eScore.com</a>, then access the portal to find a contractor through the Quality Contractor Network (QCN). You contact the QCN to schedule work performed. There will not be a charge by Southwest Tennessee EMC for this service.

The work must be performed by one of our certified Quality Contactors. You will receive cash incentives after one of our qualified inspectors performs a site visit. This site visit will take approximately one hour at your home.

# Once the site visit has been performed, you will receive:

- Your rebate based on attached rebate schedule (see back)
- The eScore of your home from 1-10 (10 being the most efficient)
- Energy saving items such as: LEDs and low flow showerheads as available.

# eScore Home Efficiency Program Upgrade Rebate Schedule

## Southwest Tennessee Electric Membership Corporation

For a member to qualify for rebates, each measure must be installed by an eScore QCN contractor.

Financing is available for electric heat pumps with no money down and low interest rate. Members pay monthly on their electric bill.

Homes with unvented gas heaters as primary source of heat are NOT eligible for rebates.

Southwest TN EMC will reimburse members up to 50% for the cost of upgrades limited as per the table below:

Attic Insulation	\$250 per home	One time only
Air Sealing	\$200 per home	One time only
Duct System	\$200 per system	One time per system
(Existing HVAC only)		
Heat Pump Water Heater	\$200 per system	No limit
Heat Pump Replacement (must be Energy Star) Ducted system or non-ducted	\$250 per unit	No limit
Tune-up for existing Heat Pump or Central Air Conditioning system	\$15 per unit	One rebate per unit per year
Central Air Conditioning replacement (must be Energy Star)	\$150 per unit	No limit
Geothermal Heat Pump (must be Energy Star)	\$500 per unit	No limit
Dual Fuel Heat Pump (must be Energy Star)	\$250 per unit	No limit
Ductless Mini-Split (primary heat source from non electric to electric)	\$250 per system	No limit
Dual Fuel Heat Pump (primary heat source from non-electric to electric)	\$500 per system	No limit
Air Source Heat Pump *Effective 12/1/17 (primary heat source from non-electric to electric)	\$1,000 per system	No limit
Conventional Electric Water Heater *Effective 12/1/17 (primary fuel source from non-electric to electric)	\$500 per unit	No limit

### The following items are not eligible for cash incentives through this program:

Refrigerators Clothes washers and dryers Radiant Barriers Programmable thermostats Storm doors Window film/solar screens Insulated garage doors Dishwashers
