The Jones Family

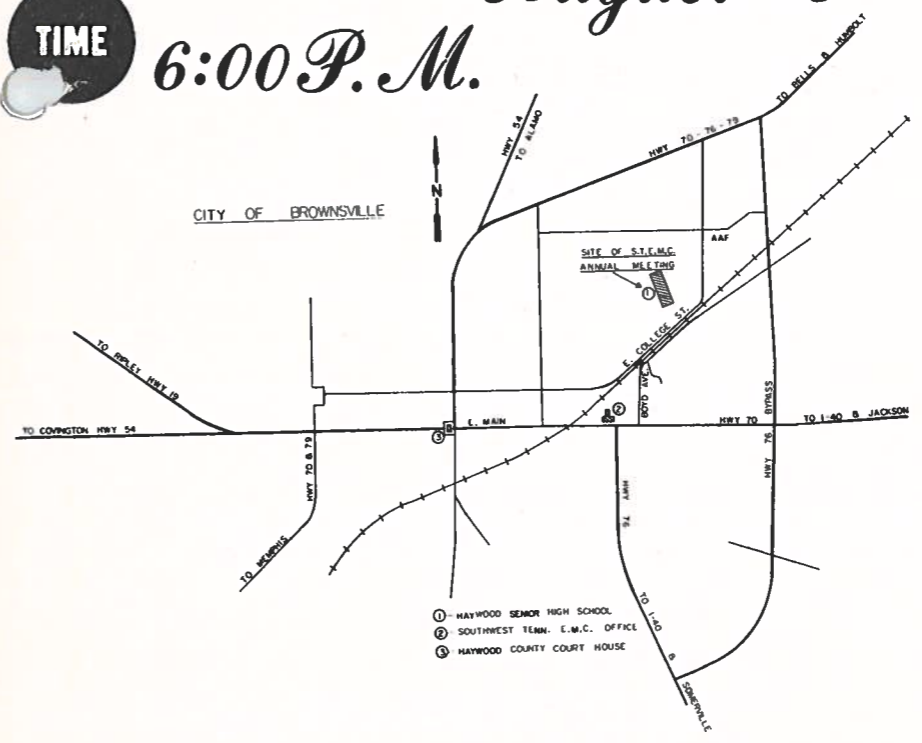
